

WORK REGULATION FOR THE CENTRE FOR JUSTICE, CRIMINOLOGY AND SECURITY STUDIES

Article 1

Center for justice, criminology and security studies operates within Faculty of Law.

The center operates within the framework of the University and in accordance with the education process and research of Bologna.

Article 2

The director operates with the center and is responsible for all its activities and scientific research publication.

Article 3

Director of the center formulates policies of actions and operation of the center, ensures that projects which the center deals with are done on time etc.

Article 4

Duties of the Center for justice, criminology and security studies are mainly:

- -Its main purpose is the development of basic scientific research work in the field of justice, criminology and security studies.
- -Center for justice, criminology and security studies should promote interdisciplinary research projects at the university
- -Center for justice, criminology and security studies deals with justice studies, criminology studies and security studies
- -Drafts different statistics
- -Consults and advices other institutions in the field of justice
- -On request of various institutions we can provide you with juridical help with experts and different projects;

The center for justice, criminology and security studies should cooperate with all other University bodies to function better;

- Cooperate with foreign institutions through which implements its projects;
- Ensure that it develops joint projects and scientific research with other institutions;
- Justice, criminology and security center should pay special cooperation with research institutes and scientific affairs, especially with university research centers abroad;

- -Center for justice, criminology and security studies can lead scientific research projects with partners outside the university with the purpose of financial gain;
- All projects that the research center conducts should also be published in University's web page
- Justice, criminology and security center should organize round tables and conferences dedicated to their work and scientific research;

Center for justice, criminology and security studies above all should incorporate in scientific research the academic community of the AAB University and its students;

- Justice, criminology and security center is free to cooperate with foreign academic staff in order to promote projects that it leads;

Center for justice and criminology should incorporate in its activities the young researchers;

- The duty of justice and criminology center is to inform the public about scientific activities and its research.

Article 5

Divisions of the centre are as follow:

- -Council of research center and
- -Director of the research center

Article 6

Director of Justice, criminology and security studies center is responsible for the center's activity and must coordinate the work with the Dean of Faculty of Law and Vice -Rector of Scientific research.

Article 7

Each center's council consists of four members :Center's director, Vice-Rector for scientific research, one member from the respective academic staff selected by the dean and one outside member from Kosovo or from international scientific community. Council's length of term is two years.

Article 8

The council's responsibility is to approve the program of the center for justice and criminology annually and to be included in research activities of the center during the year.

Article 9

Director of the center must present to the council the work program not later than 31 October of the academic year.

Article 10

Director of the center must report to the pro rector for scientific research of the centre monthly.

Article 11

Duty of the pro rector for scientific research is to coordinate the work with the Center for justice , criminology and security studies , to advise about its activity and to develop productive relations with scientific research institutions outside the University.

Article 12

Director of the architecture and arts center must submit a comprehensive report on the research's center activities to the rector's office, not later than 1st September of each year.

Article 13

Activities of the Architecture and arts center are funded from the following sources:

- -from University's budget,
- -from the State budget,
- -from grants,
- -from own commercial activity,
- -from other sources.
