### EXTERNAL EXPERT FOR THE DEVELOPMENT OF MICRO-CREDENTIAL COURSES

Project: WB-Edu4Migration

Mitigating Migration Challenges in the Western Balkans: Bridging the Skills Gap for Social Care Providers via Curricula Enhancement and Micro Credential Development

#### 1. Background:

The “WB–Edu4Migration” project, funded by the European Commission under the Erasmus+ Capacity Building in Higher Education (CBHE) program (Call: ERASMUS-EDU-2024-CBHE), addresses a critical gap in the competencies of social workers in Kosovo and Albania, particularly in their ability to effectively support migrant populations. Despite the increasing importance of migration issues in both countries, social work programs in higher education institutions have not yet fully integrated comprehensive coursework on migration studies and related topics. This educational shortfall limits social workers’ capacity to understand and respond to the unique challenges faced by migrant communities, underscoring the need for targeted interventions.

The project aims to enhance the competencies of both students and practicing social workers through a multi-phased approach that includes educational reform, the development of digital micro-credential courses, and ongoing capacity-building initiatives. By addressing foundational and continuous training needs, the project seeks to equip social workers with the knowledge, skills, and resources necessary to effectively serve and advocate for migrant populations. Its successful implementation will lead to improved higher education curricula, flexible professional development opportunities, and empowered social workers who promote inclusive practices and positive outcomes for both migrants and host communities in Kosovo and Albania.

## 2. Purpose and Scope of the Assignment

Given that micro-credentials represent a relatively new approach in higher education, not all consortium members may have extensive experience in this area. The project seeks to engage an external expert with specialized knowledge in micro-credential development. This expert will bring substantial experience in designing, implementing, and evaluating micro-credential courses, ensuring that project initiatives align with best practices and industry standards. Their perspective will be instrumental in navigating the complexities of micro-credential development, particularly in adapting to the evolving landscape of education and workforce needs in Kosovo and Albania.

### Key Focus Areas:

The external expert will play a critical role in supporting Work Packages 2 and 4 of the WB–Edu4Migration project. The specific focus areas are as following:

- Support the creation of practical and adaptable guidelines for integrating micro-credentials into university offerings as tools for lifelong learning.
- Work together with EU partners to develop targeted training on course design, digital pedagogy, and flexible delivery models for micro-credentials.
- Monitor the design process of micro-credential courses by WB partners, providing ongoing feedback to ensure alignment with identified needs and quality standards.
- Offer guidance and feedback during the piloting of micro-credential courses, to assess effectiveness and gather insights for improvement.
- Ensure that micro-credentials address real-world skills gaps and support the employability of social care providers working with migrant populations.

## 3. Timeline and Deliverables

The external expert will contribute to key activities over the course of the project implementation, in alignment with the timeline of deliverables set under Work Packages 2 and 4. The expert is expected to work in close collaboration with consortium members, particularly during the design, training, and pilot phases of micro-credential development.

### 4. Profile and Qualifications

The external expert should possess a strong background in higher education innovation, specifically in the design and implementation of micro-credentials and lifelong learning programs. Experience in the social sciences, migration studies, or social work education will be considered a strong asset. The expert must demonstrate the ability to work collaboratively in multicultural and multi-institutional environments, particularly within the context of Erasmus+ capacity-building projects.

#### Essential Qualifications:

- Advanced degree (Master's or PhD) in Education, Curriculum Development, Social Sciences, Migration Studies, or a related field.
- Proven experience in the design, implementation, and evaluation of micro-credential courses within higher education or professional training contexts.
- Knowledge of European frameworks for micro-credentials, such as the European Approach to Micro-Credentials and EQF/NQF alignment.
- Demonstrated experience with Training of Trainers (ToT) programs and capacity-building for academic staff.
- Strong familiarity with lifelong learning policies, digital learning strategies, and innovative pedagogical practices.
- Excellent analytical and writing skills, with a track record of producing high-quality guidelines, training materials, or evaluation reports.
- Ability to provide strategic and operational feedback on curriculum development processes.

#### Desirable Qualifications:

- Experience working on EU-funded projects, particularly Erasmus+ CBHE or similar international capacity-building initiatives.
- Knowledge of the higher education landscape in the Western Balkans, particularly in Kosovo and Albania.
- Experience in migration-related education and social care training.
- Ability to communicate and collaborate effectively with academic and administrative staff across institutions.
- Willingness to travel to partner countries if necessary, or attend meetings remotely.

- A methodological approach (maximum 2 pages) describing how the applicant plans to carry out the assignment, including proposed tools, phases, and work methods.
- A financial offer (in EUR), indicating the total fee (bruto) based on the expected timeline and deliverables (for 20 working days).

## 6. Selection Process

- Applications will be evaluated based on the relevance of qualifications, clarity and feasibility of the proposed methodology, cost-effectiveness of the financial offer, and previous experience with similar assignments.

Evaluation Criteria	Points	Explanation
1. Curriculum Vitae (CV)	30 points	Relevance and depth of academic and professional experience in micro-credentials, curriculum design, training delivery, and EU-funded education projects.
2. Portfolio	20 points	Demonstrated experience in developing or contributing to micro-credential courses, ToT programs, or related deliverables. Quality and impact of past work.
3. Methodology	30 points	Clarity, coherence, and feasibility of the proposed methodology. Relevance of proposed tools, phases, and work methods to the scope of this assignment.
4. Financial Offer	20 points	Cost-effectiveness in relation to the scope of work and proposed timeline. Balanced pricing and justification of total fee.
